The Preferred Strategy will focus development in the more sustainable and serviced Urban Settlements and Tier 1 Villages within the Coastal Development Strategy Area (CDSA) and Key Service Centres within the Rural Development Strategy Area (RDSA). More limited local growth and diversification will be promoted in other lesser service settlements. The Preferred Strategy also proposes a new Eastern Regeneration and Improvement Area (EIRA) to recognise the high level of constraints (e.g. flooding) within the east of the County Borough.

To The Strategic Planning Policy Service,

I write as a "lowly" resident – as we are treated in the council's scheme of things. A non-entity in everything apart from a unit, present to be extracted from as much money as possible, at every hands turn. The rest of the time – walked over and ignored.

We as a whole are bombarded by every type of pollution known to man – up until we expire, sooner than later. Chemicals added to our <u>water supplies</u>; chemical cocktails within the very <u>air we breathe</u>. All of which are responsible for the <u>tremendous increase</u> in the amount of <u>carcinogens</u>, <u>plus other health related issues</u>. retirement. The planning committee members would be well aware of these criteria – and have chosen to ignore these facts.

Horrendously increased traffic numbers – all along an already busy – "rat run" of a road (numbers increased considerably during our time here!!) I am sure the traffic counter carried out recently would agree with that statement. The extra levels of pollution, not only by all types of transport, but by wood burners too, created by these absurd proposals, which are totally unacceptable by us residents.
