Re: Conwy Replacement Local Development Plan (RLDP) 2018-2033 – Preferred Strategy Consultation

I write on behalf of Cadwgan Surgery to object to the above proposal.

We have a number of concerns relating to the RLDP:

Local general practice services are already under considerable pressure following the closure of two surgeries in the last three years, and the subsequent redistribution of their patient lists. There is a lack of capacity already and an additional 450 properties, presumably with at least 1000 new residents, would have a significant impact on existing services. Our surgery would be particularly affected given the location of the proposed development, with a projected patient list increase of 8-10%. We lack space within our existing premises to accommodate this increase.

The RLDP proposes a new surgery within the Old Colwyn development. It is not explained whether this is intended as a branch surgery for an existing practice or a new surgery. It is highly unlikely that a new surgery would be established by the Local Health Board, and there is no good reason to open a branch surgery within half a mile of our surgery, so neither of these would be workable options. It seems to us to be misleading to local residents to suggest that either option would ever materialise.
