AXIS, on behalf of FCC, agrees with the preferred vision, objectives and strategic policies contained in the current version of the RLDP, but requests that, in order that these are effectively delivered, strong consideration is given to the realignment of the settlement boundary of Llanddulas, to include the quarry element (Zones 1, 5 and 7) of the Llanddulas Quarry and Landfill Complex (Candidate Site Ref. 115).

# Local Development Plan 2018 – 2033 Preferred Strategy: **Proposed Level of Growth**

The Preferred Strategy will make provision for a level of growth comprising of 12 – 14 ha of employment land to accommodate a forecasted 1,800 new jobs. This will be supported by land for 5,150 new homes.

The preferred level of growth set out in the RLDP is consistent with that contained in Option 4 of the previous consultation exercise.

AXIS made representations at that time (Rep. ID. 27366) that this was its preferred growth option as it is aspirationally based upon the aims and objectives of the Conwy Economic Growth Strategy which trends forward past job growth. It also takes into account sectoral employment analysis and national economic trends.

Given that the growth option is job driven, in-migration sees growth in the working age population which supports the aspirations within the Draft RLDP for economic growth and a more balanced population structure.

It is considered that the preferred level of growth now being promoted is positively ambitious, yet not unrealistic, and represents the "best fit" with current and future trends.



# Local Development Plan 2018 – 2033 Preferred Strategy: **Proposed Spatial Strategy**

The Preferred Strategy will focus development in the more sustainable and serviced Urban Settlements and Tier 1 Villages within the Coastal Development Strategy Area (CDSA) and Key Service Centres within the Rural Development Strategy Area (RDSA). More limited local growth and diversification will be promoted in other lesser service settlements. The Preferred Strategy also proposes a new Eastern Regeneration and Improvement Area (EIRA) to recognise the high level of constraints (e.g. flooding) within the east of the County Borough.

Do you have any comments to make on the proposed spatial strategy? Please comment below:

AXIS continues to agree with the strategy preference for focusing development in the more sustainable and serviced urban settlements and Tier 1 Main Villages within the Coastal Development Strategy Area (CDSA), consistent with representations made at the previous stage of consultation on the RLDP (Rep. ID. 27369).

The preferred strategy will direct development in line with the Wales Spatial Plan predominantly to primary key settlements and Tier 1 Main Villages with the capacity to accommodate development.

With regard to brownfield land development, the preferred strategy has the necessary mechanisms in place to promote brownfield/despoiled land as a consequence of targeted development within and on the edge of the primary key settlements and Tier 1 Main Villages. It is acknowledged by the Council that there is not enough capacity within existing brownfield sites to deliver the proposed growth targets and that greenfield sites will be required, potentially facilitated by amendments to settlement boundaries.

FCC owns the Llanddulas Quarry and Landfill Complex which lies to the southwest of the Tier 1 Main Village of Llanddulas, which adjoins its settlement boundary. FCC is currently considering redevelopment options for the Quarry Complex which would be ideally located to accommodating a sizeable proportion of the housing and employment development requirements, thus assisting in meeting the development needs of the Eastern CDSA.

Rather than submitting any comments on specific Candidate Sites, clarification is sought on the classification of strategic sites.

The Candidate Sites Assessment Process document (see "Stage 4 Preferred Strategy") indicates that strategic sites are considered to be over 3ha in size - to provide more than 100 dwellings or 10,000m² of employment floorspace.

However, the Preferred Strategy document itself indicates (see page 8) that strategic sites are "...classed as being 6 hectares (60,000 sqm) or more, which could include a specific use or a mix of uses."

Clarification on this apparent inconsistency would be welcomed in future stages of the plan-making process.
